I was able to perform a desktop review and site visit this morning. Below please find the official determination.

June 21, 2018 INF-SC-2018-13-01928

RE: Request for Navigability Determination on an unnamed tributary of the Yahara River, located in the SE Quarter of the NE Quarter of Section 17, Township 5 North, Range 11 East, Town of Dunkirk, Dane County.

I performed a desktop review and visited this site on 6/21/2018. I inspected the waterway on the East and West sides of Brookside Circle. To the West of Brookside Circle, the waterway had steady base flow. The water was approximately 6 inches in depth and the waterway was approximately 1.5-2 feet in width with a meandering nature and a gravel substrate. The waterway continued to flow East, under Brookside Circle, to the Yahara River. The waterway on the East side of Brookside varied in depth between 6-12 inches and was approximately 2.5 feet wide. The waterway was assessed at a time of high water.

In Wisconsin, the Supreme Court has defined a navigable waterway as one which has a defined bed and banks and carries enough water to float a canoe or other watercraft during the spring high water periods. Based on this definition and the conditions observed at your site, *the stream on this property has been determined to be NOT navigable/public*. The waterway has a defined bed and bank, but would not be deep enough to float a watercraft even at this time of high water.

Chapter 30, Wis. Stats., permits are not needed for work in and near this waterway. However, *the waterway does meet the definition of a watercourse and would be subject to Chapter 31 Dam regulations for any activity that may impound water. Furthermore, the waterway runs through an area indicated as wetlands. Any land disturbing activities in this area would require authorization through the DNR wetland program.* Information on these regulations are available on the DNR web site at www.dnr.wi.gov.

Certain activities may also require permits from the Army Corps of Engineers and they should be contacted before beginning any construction at this site.

Hi Amy,

Any waterway that meets the definition of a "navigable" water, regardless of its size (brook vs river) is subject to Chapter 30 waterway regulations. The pictures you supplied indicate a defined bed and bank, however to determine whether it is a navigable water I would need to take a closer look and perform a desktop review.

As far as setback requirements and other ordinances, those should be the same, but you will want to check with the County.
